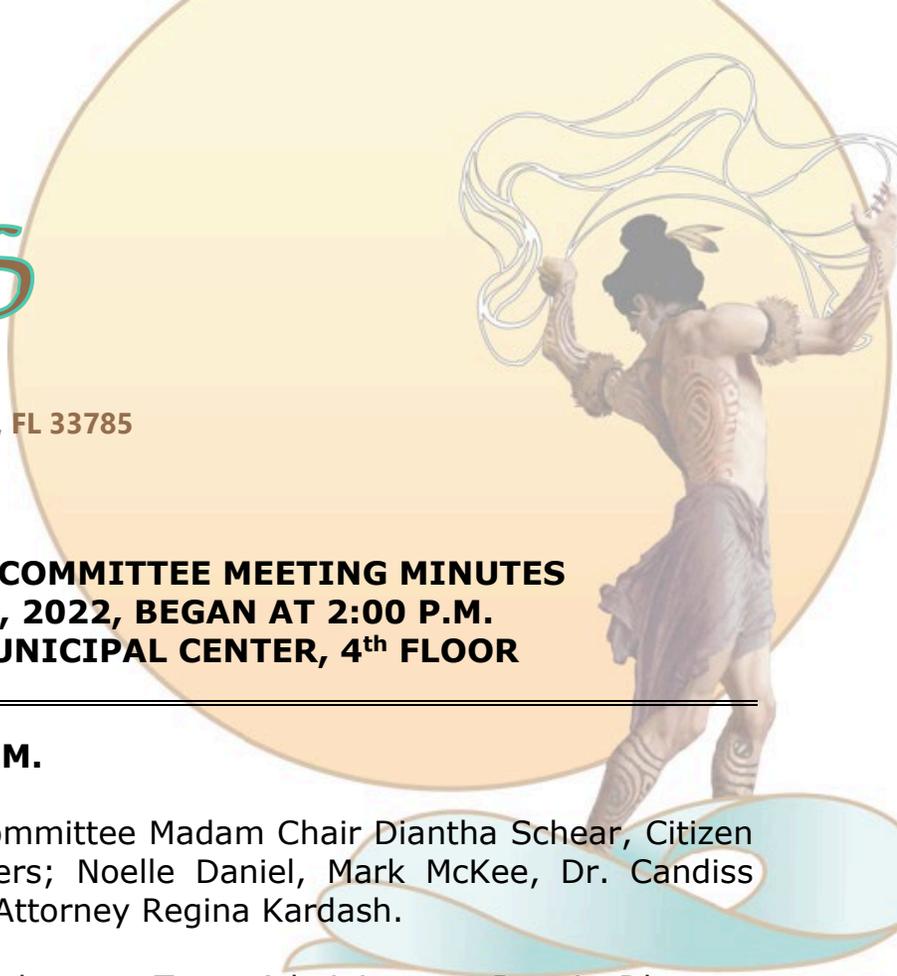

audit, he clarified that their firm has resources ready to mobilize immediately upon any approval or execution of a contract with their firm. He added that they have plenty of availability and capability to meet the August 31, 2022 deadline.

**Attorney Kardash** noted that the language in paragraph 11 of the terms and conditions provides that the client shall indemnify James Moore. She requested that the language be stricken or allow her to redraft the terms and conditions to consider the Town's sovereign immunity as a government entity. Mr. Chalifour did not see a problem with making the adjustments as needed.

The Committee submitted their scores for the ranking in writing. Mr. McKee read his scores aloud for the record, and they were:

- CS&L CPAs = 84
- James Moore = 91
- Saltmarsh, Cleaveland & Gund = 45

The Committee's cumulative scores per firm were provided by the Town Clerk to determine which ranked the highest. The results were read in the following order:

- CS&L CPAs = 443
- James Moore = 473
- Saltmarsh, Cleaveland & Gund = 229

**Madam Chair Schear** announced that James Moore ranked the highest and was comfortable awarding their firm as the Town's auditors.

**Motion** by **Dr. Rinker** – seconded by **Mr. McKee** to recommend James Moore & Co., P.L. as the Town's auditors for Council consideration. **All ayes. Motion carried 4-0.**
