

Proclamation



DECLARATION OF STATE OF LOCAL EMERGENCY HURRICANE/TROPICAL STORM ETA

Whereas, The Pinellas County Board of County Commissioners met on November 11, 2020, 11:00 a.m., concerning the potential threat of **Hurricane/Tropical Storm ETA** and has declared a **Local State of Emergency**.

Whereas, the Pinellas County Board of County Commissioners has authorized the designation of the Sheriff's Chief Law Enforcement Officer and delegate authority to the County Administrator to conduct evacuations, disaster related debris removal, and appropriate funds as necessary to respond to this emergency; and

Whereas, a quorum of the Town of Indian Shores Town Council met on November 11, 2020, 1:00 p.m., **declaring a State of Local Emergency** as provided by Chapter 26-72 of the Town Code.

Now, Therefore, be it proclaimed that I, Patrick C. Soranno, Mayor of Indian Shores, Pinellas County, Florida, in coordination with the Town Council of Indian Shores, Florida, do hereby proclaim pursuant to Chapter 26-72 of the Town Code, a State of Emergency exists in the Town beginning at 1:00 p.m. on November 11, 2020.
